## TERMS OF THE EXCHANGE BOOK PURCHASE PLAN

The Exchange Book Purchase Plan is set up to provide the members of the Rochester Philatelic Association with the opportunity to submit and receive philatelic material. To this end, members who submit or accept material should do so only in full agreement with the following terms:

- 1. A member accepting an exchange book must indicate receipt of same by signing his or her name and dating a record sheet in the possession of the Exchange Book Purchase Plan manager. A member removing stamps from the Exchange Book Purchase Plan book should initial in ink each square from which a stamp is removed. Books are to be returned with cash for the stamps withdrawn or lost to the manager or one of the club's officers, appointed in the absence of the manager. At the time of return, the manager or the alternate will initial the record sheet in the presence of the party returning the book thus indicating receipt of same.
- 2. A member accepting a book at one meeting holds himself responsible for returning the same in good condition by the next consecutive meeting of the club. Holding a book for longer than three consecutive club meetings will be sufficient reason for requesting the member to withdraw from the Exchange Book Purchase Plan. Members losing or damaging the material are responsible for the value lost or damaged.
- 3. A member may obtain an Exchange Book Purchase Plan book for five cents from the manager. On submitting a book for circulation in the Exchange Book Purchase Plan, a member will obtain a receipt for same from the manager and at that time pay a charge of fifteen cents for each five dollars net value or part thereof contained in the book to cover loss or theft during circulation, excluding the period of time during which an individual club member has signed and assumed full responsibility for said book as described under Section 2 above.
- 4. All stamps submitted are to be identified by the correct Scott's catalog number and latest catalog value as well as the net price expected to be received for the stamps. Space is provided for the same under each stamp and should be clearly marked in INK.
  - 5. Torn or damaged stamps are not to be submitted.
- 6. No member shall have more than three books in circulation at any one time and no book shall contain more than ten pages of stamps nor exceed a net value of \$25.00.
- 7. A fee of ten per cent of the amount sold in the Exchange Book Purchase Plan will be retained by the manager at the time that the book has completed its circulation and is returned to the owner. At the time the unsold material is returned to the owner, he or she is to surrender the receipt held for the book.
- 8. Any member who does not feel that he or she can freely agree to and fully accept all the terms detailed above should refrain from participating in the Exchange Book Purchase Plan.
