

Open Classes

Gold, Silver and Bronze Medals, donated by the Rochester Philatelic Association, will be awarded at the discretion of the Judges. The Best-in-Show award will be given in lieu of a gold medal. Included in additional awards are:

Uncle Billy Stone Award, donated by Louis S. Werner, for the best exhibit by an APS member.

APS Silver Medal, donated by the American Philatelic Society, for the best research exhibit by an APS member.

Ingeborg Herst Memorial Plaque, donated by Mr. and Mrs. David Kent, for the best exhibit by a woman exhibitor without reference to membership in the APS.

George Ritter Memorial Trophy, donated by the Tampa Collectors Club and the Florida Philatelic Society, for the best exhibit entered by a first-time exhibitor.

James T. DeVoss Award, a plaque donated by James T. DeVoss, for the best U.S. Possessions exhibit. U.S. Possessions are defined to include only those possessions listed in Scott's Specialized Catalog.

The President's Award, donated by APS President Edward L. Willard, for best U.S. or Spain exhibit.

Postal History Bronze, Silver and Gold Medals as well as a Grand Award for the best postal history entry, awarded by the Postal History Society of the Americas to participating members of their society.

Marcus White Trophy, awarded by the United Postal Stationery Society for the best postal stationery exhibit.

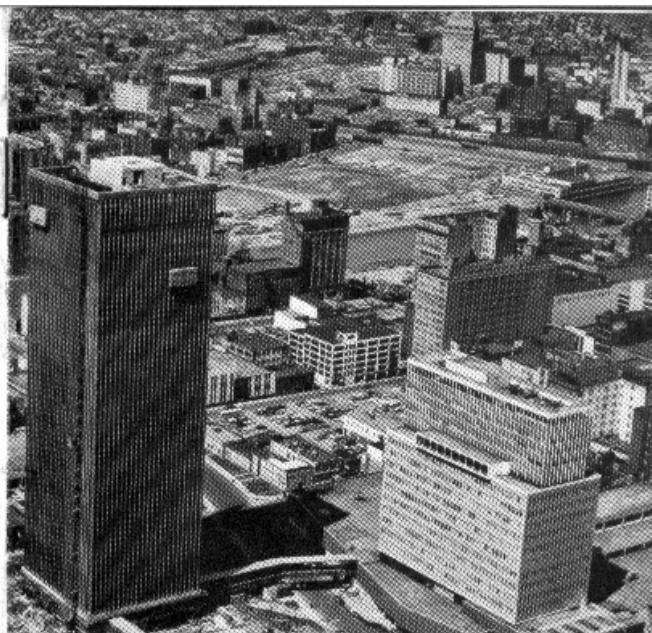
Postal Stationery Research Trophy, awarded by the UPSS, for postal stationery exhibit showing most research.

Postal Stationery Certificates, awarded by UPSS, to other best postal stationery exhibits.

Exhibition

APS-68 will be held September 19, 20, 21 and 22 in the Sheraton Hotel, 111 East Ave., Rochester, N.Y. 14604.

Hours for the show will be: Thursday, Sept. 19th 10 A.M. to 10 P.M. Friday, Sept. 20th 10 A.M. to 10 P.M. Saturday, Sept. 21st 10 A.M. to 10 P.M. Sunday, Sept. 22nd 10 A.M. to 5 P.M. For the first time an APS show will feature a special section—the Grand Championship Section—open only to grand award winners of the major open national stamp exhibitions. These exhibits will compete only among themselves for the "best in the Nation" during 1967-68.

The rest of the show will be open competition with awards of gold, silver and bronze to be awarded at the discretion of the judges. The best in show award will be given in lieu of a gold medal. Other special awards will be provided.

First Day—World Weather Watch

The United Nations will release the 6-cent and 20-cent World Weather Watch stamps September 21 to coincide with the opening of the exhibition. The new stamps will be on sale first day at the show at a special U.N. philatelic sales unit. Activities throughout the convention will tie into the theme of the World Weather Watch.

Special Postal Services

The United States will establish an APS-68 postal station and the United Nations a stamp sales office at the Sheraton Hotel to serve collectors. The U.S. postal station will sell current commemoratives and provide the official APS-68 cancellation. The United Nations will offer current stamps for sale including the new World Weather Watch stamps which will be issued September 19, opening day of the convention.

Cachet

The APS-68 cacheted covers will be available fully serviced on mail order or at the exhibition. The price of the cacheted covers will be 25¢ each or four for \$1.00.

Bourse

Tables will be filled by 20 dealers. The Bourse will be open during Exhibition hours.

Lectures and Seminars

The Rochester Philatelic Association in cooperation with participating societies will conduct lectures and seminars on stamp collecting and related subjects on Saturday and Sunday.

RULES AND REGULATIONS

1. This exhibition is open to any stamp or cover collector regardless of society affiliation. All material exhibited in competition must be the property of the exhibitor.
2. The committee reserves the right to reject any exhibit in part or whole and to determine the proper class (section) even if different from that selected by the exhibitor on the Official Entry Form.
3. The frame size is 36 inches wide by 48 inches high arranged in four horizontal divisions, each 12 inches high. Each frame will hold 16 pages, 9 x 12 inches. Larger pages must overlap.
4. Exhibits are limited to 5 frames of 16 pages each. The fee of \$5.00 for each frame or part thereof used by each exhibitor must be received with the signed entry form. If more than one exhibit is entered, exhibitor must fill out a separate form for each exhibit.
5. The Exhibition Committee reserves the right to reject any exhibit without assigning any reason for such rejection. Fees received for entries not accepted will be returned.
6. Decisions of the judges with regard to classification and awards shall be final.

to arrive no later than August 1, 1968.
8. Exhibitors will be notified by mail at an appropriate time if their entry is acceptable. If it is accepted, they will be advised of the bank address to which their exhibits should be forwarded for safe-keeping, and the period of time within which exhibits should be received. Exhibitors who wish to bring their exhibits or have them personally delivered should so indicate on the entry form and must receive written approval from L. J. Roll. No such exhibit will be accepted on the exhibition floor after 6:30 P.M., September 19, 1968.

9. Exhibits will be returned at the expense of the owner, as soon as possible after the close of the exhibition, in the manner designated by the owner if prepayment is enclosed. Unless other instructions are given, they will be returned by Railway Express, collect charges and insured for \$100.00. The Committee recommends the inclusion of return postage as the most economical.
10. APS-68 will provide limited insurance above that carried by the owner for each exhibit during the period the exhibit is in the possession of APS-68. Although all reasonable care will be taken of the exhibits, no liability will be attached to the American Philatelic Society or the Rochester Philatelic Association, nor to any of its voluntary assistants or employees, for any loss or damage to an exhibit arising from any cause or reason whatsoever.
11. The Lincoln Rochester Trust Co. will receive all accepted exhibits. It will acknowledge receipt of all exhibits and their condition as received.
12. All exhibits will be mounted and dismounted by members of the Exhibition Committee or its authorized assistants. No exhibit may be dismounted before the closing time of the Exhibition at 5:00 P.M. Sunday, September 22, 1968.
13. The decision of the Exhibition Committee on all questions that may arise concerning the Exhibit shall be final.
14. The signature of an Exhibitor on the Entry Form shall indicate acceptance of these Rules and Regulations.

AWARDS

Grand Championship Class

The Grand Award winners of the major open national stamp exhibitions held between July 1, 1967 and June 30, 1968 will be invited to compete for the Grand Championship Award. These exhibits will compete only among themselves and will not be eligible for other awards. Each entry, however, will receive suitable recognition of the honor of participating in this class.
