



1907 - 1980

The following stories are taken from Jim Flynn's article "Revolutionary History" which appeared in the ROPEX-76 Program and are reprinted here as a remembrance.

During the Revolutionary War, many foreign mercenary soldiers sought asylum in this country. They feared that they would be sent to other wars if they returned to their native Hesse. One such sickly Hessian soldier married and settled in a Pennsylvania town. Too sickly for the robust work of farming, he opened a small store. He made sausages and his wife made salads and baked goods for him to sell. The people liked his store and admired his pluck, despite his delicate health. They frequently told their friends to go over to the Delicate Hessian's Store and buy some of his good food.

One day, while his wife was out on an errand, the Hessian waited on a man who wanted some sausage. Having no money, the customer offered the shop-keeper a fine bird that he had shot and the deal was concluded. Later when the Hessian's wife returned, he related the transaction. Locking at the bird his wife said, "It looks like you have taken a Tern for the Wurst".

Many have heard Washington's famous words to his officers enjoining them to, "Let none but Americans be on guard tonight". However, many do not finish the saying which continued, "and let the Irish sleep, for there's going to be a great deal of fighting in the morning"
